SECTION 4. FIRST AID MEASURES

4.1. Description of first aid measures

General notes

Remove affected person from the contaminated area to fresh air or well-ventilated area, providing her basic life functions and protect it from the cold or heat. Never give fluids or provoke vomiting if the victim is unconscious. Call the doctor and give him the information on the packaging and/or on the instructions for use of the preparation.

Following inhalation

Comply with general measures. Remove patient to fresh air-move out of dangerous area. If symptoms persist seek medical attention.

Following skin contact

4.2. Most important symptoms and effects, both acute and delayed

Inhalation

Breathing dust can irritate the respiratory tract.
Coughing, sneezing, nasal discharge, labored breathing.

Skin contact

Contact with skin may cause irritation (redness, itching).
Powder can cause localised skin irritation in folds of the skin or under tight clothing.

Eye contact

It can cause shortterm irritation.
Dust irritates the eyes (by mechanical means).

Ingestion

Difenacoum is an anticoagulant which may produce bleeding; this may be delayed for several days after exposure.
In case of poisoning bleeding disorders and increased bleeding tendency may occur.
In severe poisoning a strong internal bleeding can cause circulatory collapse and consequent death.

4.3. Indication of any immediate medical attention and special treatment needed

In the case of accident or if you feel unwell, seek medical advice immediately (show the label where possible). **ADVICE FOR DOCTORS:** Difenacoum is an indirect anti-coagulant. Phytomenadione, Vitamin K1, is antidotal. Determine prothrombin time not less than 18 hours after consumption. If elevated, administer Vitamin K1 until prothrombin time normalises. Continue determination of prothrombin time for two weeks after withdrawal of antidote and resume treatment if elevation occurs in that time.
